What is the Security Council Committee?

The Security Council Committee is responsible for maintaining global peace and stability. Having these been said, you, chairs and delegates, are about to face issues caring major significance for people all around the globe. As you may imagine, top significance equals special debating procedure as described underneath these lines.

Procedure

The Security Council Committee (S.C.) is a committee which does not participate in the General Assembly (G.A.). When writing a resolution for the Security Council Committee, either prior to the conference or whilst lobbying and merging, besides the “typical” opening phrases (*Emphasizing, Calls upon, etc*) you are able to use some more opening phrases such as: **Condemns** and **Demands**.

The lobbying, merging and alliance creation procedures are conducted the same way as they are introduced in G.A.

Furthermore, the debating procedure is conducted CLAUSE BY CLAUSE which means that you are going to deliver speeches, propose amendments and vote on each clause separately and NOT for a resolution as a whole. This happens on a primary level. After all clauses have passed/failed/amended, there comes a voting procedure upon the whole resolution as it has been formed.

Special Motions

In the Security Council we have the motions described on the study guide for the G.A. committees with the addition of VETO.

Veto, is a motion that can be only proposed by the Permanent Members of the S.C. (**China, France, Russia, The United Kingdom and the United States**). It may be proposed during the debating procedures either for an amendment or an operative clause (only by the delegations mentioned before). When a veto is proposed, those countries are exiting the room with one of the chairs in order to discuss whether to overrule or not the clause upon which the veto was proposed. There will be a maximum of 5 minutes to each discussion upon the veto. No limitation upon the number of vetoes that can be forwarded by a delegation is in effect.
